THE FALKIRK COUNCIL (ON-STREET PARKING SPACES FOR DISABLED PERSONS REVOCATION) (VARIOUS STREETS NO 7) ORDER 2022

Falkirk Council in exercise of their powers under the Road Traffic Regulation Act 1984, as amended (hereinafter referred to as “the 1984 Act”) and of other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby make the following Order:-

1. This Order may be cited as “Falkirk Council (On-Street Parking Spaces for Disabled Persons Revocation)(Various Streets No 7) Order 2021” and shall come into operation on the 9 day of March, Two Thousand and Twenty Three.
2. This Order hereby revokes The Falkirk Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Decriminalised Parking Enforcement and Consolidation) Order 2018 insofar as it relates to the disabled persons parking bays described in the schedule as indicated on plans listed in the schedule.
3. The effect of this Order will be to remove the designated sections of road described in the Schedule hereto as a parking space for disabled persons vehicles.

On the west side of Bulloch Crescent from a point 19 metres north of the projected south building line of block 66-72 in a northerly direction for a distance of 6.6 metres or thereby.

On the north side of Zetland Drive from the projected east boundary line of 18 Zetland Drive in a westerly direction for a distance of 6.6 metres or thereby.

Almond Street, Grangemouth

On the north side of Almond Street from a point 1 metre east of the projected west boundary line of 46 Almond Street in an easterly direction for a distance of 6.6 metres or thereby.

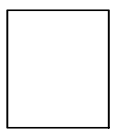
